Entry fees are due May 5, 2008. There will be a \$100 penalty assessed for payments postmarked after the deadline. Entry fees for the Klamath Reined Cow Horse Classic are \$1,000 for the Open, \$1,000 for the Non-Pro, \$500 for the Amateur and Limited Open Divisions. Those entering the Intermediate Open must pay \$350 per Division and be entered in the Open Division. Those entering the Intermediate Non-Pro Division must pay \$350 and be entered in the Non-Pro Division. Klamath Reined Cow Horse Classic is open to horses 4 & 5 year olds shown in the Hackamore or Snaffle Bit. Horses must be shown in a hackamore as described in the general rules for equipment. The rider shall use closed reins. Two hands must be used on the reins, except in the herd work. The NRCHA Rule Book contains the rules for Limited Aged Events, and will be followed as printed. Both owner and rider must be current 2008 NRCHA Members. Entries are not valid without payment in full. NO CALL ENTRIES PLEASE!
